CALL MEETING TO ORDER

Mayor Winslow called the regular meeting of the Standish City Council at 6:00 p.m.

2. PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA

Mayor Winslow requested that items D. Medical Marijuana Ordinance and E. Addendum-City Assessor Contract be removed from the agenda.

MOTION by Nelson and supported by Ireland to approve the agenda as amended. The motion carried.

6. APPROVAL OF MINUTES

A. IFT Abatement Reports

Representatives from Arenac Castings reported that they current have 33 employees back to work as of May 20, 2010 and expect to have more in the coming weeks.

The Clerk reported that Paul Aultman had called earlier in the week to report that Vantage Plastic now had 83 employees working.

NEW BUSINESS

A. REWARDS FOR RECYCLING PRESENTATION

Moran introduced Preston Hards, Marketing Director for Rewards for Recycling, who gave a brief presentation on the program. Hards stated that the program will work hand in hand with the Chamber of Commerce as well as the City's contracted waste hauler. Hards stated the estimated additional cost to each household would be \$35.00 per year.

Council discussed the program and felt that they needed to contact and educate their constituents prior to making a decision. Mayor Winslow requested that this item be placed on the agenda for the regular Council meeting of June 17, 2010 for a decision.

B. KIWANIS RACE - JULY 17, 2010

Josette Rang appeared before Council and requested permission to close some City streets for the July 17, 2010 Kiwanis Race. Rang stated that she is only requesting that one lane of the streets for the race route be closed and that she has spoken to the Police Chief regarding this issue. Rang stated that last year's race had 127 participants.

MOVED by Nelson and supported by Macaulay permit the closing of City Streets for the July 17, 2010 Kiwanis Race with the route to be agreed upon and approved by the City of Standish Chief of Police and Ms. Rang. A roll call vote was taken.
